Dogs must be registered with the North American Sport Dog Association. Registration is a one-time fee. You may register your dog online at <http://nasda.dog/registration/>

Awards:

Awards will be handed out at the conclusion of the trial. Ribbons are awarded for qualifying score, and High in Trial. New title ribbons will be awarded. Non-Bonus point ribbons will be offered for highest scoring dog per class each day and top scoring dog by breed.

Venue:

Exhibitors will be crating in their vehicles. **Terrier Performance Club of Northeast Oklahoma (TPC NE OK)** reserves the right to remove any individual for any reason from the premises. No refunds will be issued. Please pack food and water for you and your dog. Absolutely no alcohol or drug use allowed during the trials. If suspected, you will be asked to leave immediately with no refund and your entries will not be accepted at any future Terrier Performance Club event.

It is not appropriate to visit the trial locations prior to the trial date. Many search area locations are real-life environments and such visits may risk the host losing the opportunity to use the location in the future.

Notice to Exhibitors:

- Refunds will be mailed 7 days after the event.
- Payment processing fees will be subtracted from refunds, if applicable.
- No refunds for cancellations after the closing date.
- No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- Dogs exhibiting illness, injury, or lameness will be excused.
- Dogs must be on leash at all times except when competing.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- Please be courteous and pick up after your dog.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$40 fee for any returned check or payment. Checks must be made payable to **TPC NE OK**.
- **TPC NE OK** reserves the right to refuse any entry without cause or explanation.
- Trial begins at 12:00 PM (noon), weather permitting. The start time may be adjusted each day due to weather conditions.
